MISCELLANEOUS REMARKS

Mayor Infante: The contract with Vectren for our opt-in gas has been finalized. Neil spent the weekend negotiating the price and it kept going down. It started out at about \$11.58 and he got it all the way down to \$10.39 on Friday. Neil will be finalizing that tomorrow and signing the contract. We will have everyone a !-800 number and they can call and also Vectren will be sending postcards to all the residents to sign up. Neil has instructed Tom to put it on the utility bills.

Councilman Papalas: Law Director Dull where are we on the bike trail and that railroad issue?

Law Director Dull: I just got an e-mail this afternoon that we are in agreement (inaudible) certify the right of way and they are going to mail the original document to me. I expect to get it next week or the end of this week.

Councilman Papalas: What will be the next step?

Law Director Dull: From our end we just have to record those documents and then Mark is the person that is working up the certification(inaudible).

Mr. Mark Hess: Then we have to send the certification to ODOT that we acquired the right of way. We already started that. Right now the project is sitting in Columbus and we had to make some changes in the (inaudible) package and our engineers are working on that, just minor changes because it has been sitting so long. We are probably looking at next February or March.

Councilman Papalas: Thank you. Tom do you think that the e-mail will be fixed by next meeting?

Councilman Papalas: So when do you think that it will be taken care of?

Mr. Telego: Tomorrow morning.

Councilman Papalas: Thank you.

Councilman McCormick: I just want to commend those who worked on the gas rate. It is my understanding that this is just an option. If you choose to use the Vectren rate you can, but if you have another company you want to use you can use them. You are not restricted to that one particular company. We are locked in to a good solid rate and if the market goes down you can still buy your gas from someone else, you don't have to buy from this company. We are locked into a rate we can live with and I do want to commend the mayor, Neil and especially Dave Wilkerson who helped get this going too.

Councilman Papalas thanked the Boy Scout Troop 143 for coming out to the council meeting and wished them success in obtaining their merit badges.
