#### MEMBERS OF THE AUDIENCE TO ADDRESS COUNCIL

Mr. Robert Faith, 1411 Difford Drive, Niles, Ohio: I am a member of Local 2155. I am here to speak about the America Free Choice. This is about the economy and we have a lot of our steel mills shut down. Anything that the government is buying to build bridges, buildings, and schools is to buy American products. This is not any way violating any trade laws. This will help create jobs, will help our steel mills going, taxes paid to the cities and towns, sales tax will buy stuff. This is a win-win situation. With the stimulus package that just passed there was a thing in there that was put in by the U.S. Congress to buy American. If there is any questions or anything that I can help you with I will try to answer any question.

Councilman Scarnecchia: Three years ago from a local G. M. Dealer I leased a Pontiac Torrance. I found out afterward that the whole thing was made in Canada. Am I buying American or am I buying Canadian?

Mr. Faith: This is just going into effect now, I have a Torrance. The parts were made some where else, but it was assembled in one of the U.S. plants. That was kind of a way that they said it was American, but a lot of the parts came from Canada. This is something that we are trying to change, that the parts be made in the United States. Everybody knows that the auto industry is in the tank, this would help. The suppliers will hopefully rebuild the car industry. There is nothing that can go wrong, this will help the country. It will help pay the city tax because when you have the clients working you get revenue from them.

President Marino: We also in the resolution we supported encourages we as a government body to purchase products made in the United States whether we receive those monies or not. In particular if we receive those stimulus dollars we purchase American made goods.

Mr. Todd Weddell of 884 Nancy Street, Niles, Ohio: I am president of Local 2155. What we want to do is have our city, our community right around here to buy American. That is basically what

the whole package is and what Bob is trying to talk about. It does talk about the fact that our steel mills are closing. As you know every day our steel mills are closing, WCI is probably working at three hundred out of fourteen hundred. I feel as part of this community as part of this state that it is our responsibility to endorse this.

Councilman Scarnecchia: To finish up my remark first thing I agree with you one hundred percent. It would be a perfect world if everybody would buy American. About fifteen years ago, our congressman from this district was very strong on the buy American. Because of the greed of companies and officials but, they will find a way to turn it around. We have to stay positive because we know what has happened in the past.

Councilman Papalas: We have shown support for you tonight by already passing what we just did. We will do anything that we can for you and I know all of us feel that way. In adding to what Tom just said I really do believe that our government needs to revisit all those NAFTA agreements and reconstruct that plan because I don't think it has helped us as we thought it would.
