# AN ORDINANCE REPEALING A MOTOR VEHICLE LICENSE TAX ENACTED BY ORDINANCE NO. 21-09; AND, DECLARING AN EMERGENCY

It was moved by Papas, seconded by Stredney to give this Draft a first reading.

President Pro-Tem Papalas: This ordinance is the result of a pledge we made to the community in June that if the license plate fee increase didn't take place in the county we would rescind our own. The reason we passed this is because we wanted the funds to come directly to Niles not to be used by the county. We have had other developments that we just learned about. These developments we discussed at the meeting in the mayor's office.

Mayor Infante: We found out that to rescind it, it won't take effect until 2011. We didn't know that the Bureau of Motor Vehicles logs in their computer system throughout the state of Ohio ninety days prior to the end of the year. You are allowed to renew your license three months ahead of time. They are going to start charging that ten dollars. At our Finance Committee Meeting today we thought that we would get this ball rolling and we are going to collect another a hundred and eighty thousand dollars that will sit in Permissive Tax Fund. We talked about scheduling a public hearing to get their input on it and putting some projects together to see if the public would be interested in letting us use that money for a project. If there is a big outcry and they want the ten dollars rebated, we will have to find a solution in refunding it through a utility bill. There are nineteen thousand licensed motor vehicles in Niles that get registered every year. Our intentions were great and now we are trying to be honest and let everyone know. You couldn't rescind it before the election and three months prior to the end of the year they set their computers up throughout the state.
