ORDINANCE NO. ___(Draft No. 73-13)

AN ORDINANCE AMENDING CODIFIED ORDINANCE NO. 141.11, "ALARM RESPONSE FEE" TO CREATE NEW FEE ASSESSMENTS BEGINNING IN THE CALENDAR YEAR 2014

It was moved by Stredney, seconded by Merlo to give this Draft a second reading.

Councilman Papalas asked the police chief what the policy is concerning a business alarm going off two or three times. Chief Hinton said that businesses are given three free alarm activations in a year. If in the case of a power failure or weather related there is no charge. If the alarm goes off and you can contact the police department before the officers respond to the alarm activation there is no charge. This amendment to the ordinance is to encourage employers to train their employees on their alarm system or to make repairs to their faulty alarm systems.

Mayor Infante announced that the city received a \$386,000 grant through the Public Works Commission for North Main Street resurfacing, the work is to be done next year.

Auditor Nader spoke to council about the transfer of cash to Capitol Projects that was passed at the last council meeting. The \$300,000 was divided between \$200,000 for Brownfield Restoration and \$100,000 was for paving. Auditor Nader reminded council and the Utility Committee again to starting looking at the water and sewer rates.

Councilman Stredney: Chief, did we get that fire truck back yet?

Fire Chief Brown: We do have it back and it is with the mechanics right now. There are a couple little problems, but I think it will be back in service as soon as we get some parts.

Councilman Merlo: I know at the last meeting we tabled the ordinance for the billing software in the Utilities Office. I ask my fellow council members to take a minute to talk to the workers in that department to really see the issues they are having. I know that we are acting on forming a committee and I think that we are heading in the right direction, but you truly need to see the issues that they are having there.
