BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NILES, STATE OF OHIO:

ORDINANCE NO. _____

AN ORDINANCE PLACING A MORATORIUM ON THE AUTHORITY OF THE ZONING AND BUILDING INSPECTORS TO ISSUE PERMITS ALLOWING FOR THE SITING AND CONSTRUCTION OF TELECOMMUNICATION TOWERS AND ATTENDANT FACILITIES WITHIN THE CITY; AND, DECLARING AN EMERGENCY

Whereas, the Building and Zoning Inspectors have raised concerns that the City has not studied whether the siting and construction of Telecommunication Towers and attendant facilities should be the subject of legislation; and,

Based upon these concerns, Council desires to place a moratorium for a period of time on the authority of the Zoning and Building Inspectors to issue permits for the siting and construction of these towers and facilities to allow for a study to be conducted and recommendations made.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NILES, STATE OF OHIO:

SECTION 1: For purposes of this Ordinance, the term "Telecommunication Tower" shall be defined as a structure intended to support equipment used to transmit and/or receive telecommunication signals, including (but not limited to) monopole, guyed and lattice construction steel structures..

SECTION 2: Council hereby places a moratorium for a period of six months on the authority of the Zoning and Building Inspectors to issue permits for the siting and construction of telecommunication towers and attendant facilities within the City to allow the Safety Committee to study whether there is a need for regulation of these structures.

SECTION 3: This Ordinance is hereby declared to be an emergency measure in the interests of the public health, safety and welfare for the reason that the immediate implementation of this measure will prevent further construction of these structures until the study has been completed. As such an emergency measure, this Ordinance shall take effect upon passage by Council and approval by the Mayor.
