A RESOLUTION AUTHORIZING THE APPROPRIATION OF FUNDS FROM THE UNAPPROPRIATED WATER FUND AND UNAPPROPRIATED SEWER FUND TO THE WATER EQUIPMENT PURCHASE ACCOUNT AND THE SEWER EQUIPMENT PURCHASE ACCOUNT; AND, DECLARING AN EMERGENCY

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NILES, STATE OF OHIO:

SECTION 1: Council hereby authorizes the appropriation of Thirty Nine Thousand, Eight Hundred Thirty Two and 50/100 Dollars (\$39,832.50) from the Unappropriated Water Fund to Water Equipment Purchase Account, Account No. 501-5151-56300.

SECTION 2: Council hereby authorizes the appropriation of Thirty Nine Thousand, Eight Hundred Thirty Two and 50/100 Dollars (\$39,832.50) from the Unappropriated Sewer Fund to Sewer Equipment Purchase Account, Account No. 503-5353-56300.

SECTION 3: This Resolution is hereby declared to be an emergency measure in the interest of the public health, safety and welfare, for the reason that the funds are needed to complete the installation of the water meter project. As such an emergency measure, this Resolution shall take effect upon passage by Council and approval by the Mayor.
