Mayor Mientkiewicz said they are watching the Street department and the Water department. Mayor Mientkiewicz said the only overtime right now is call outs. Mr. McNaughton said everything is looking a lot better than it did months ago. He wanted to give credit to the department heads and the city workers for these numbers being as low as they are.

MEMBERS OF THE AUDIENCE TO ADDRESS COUNCIL

(Public remarks began at 4:05 into recording)

Paul Davis: 44 Hartzell Ave. Niles, Ohio. Mr. Davis asked where the proposed dog park was being placed in the park. President Steffey explained it be where the two small unused baseball fields are in Waddell Park. Mr. Davis said those are fields are unused due to a poorly run youth league baseball. He has been up at council before numerous times about this. Back in 1952, pony league baseball was brought to Niles. About the same time, little league baseball was brought here as well. He was one of the first players in the leasue.

After many years of baseball being gone, his group brought the pony league and little league baseball back. They had approximately 750-800 kids participating in their youth league. They used both of those fields President Steffey is talking about. Thanks to Carmen Vivolo, who was Recreation Director then, they rebuilt those fields and invested quite a bit of money in them. Unfortunately now, people aren't going to pay the kind of money they are charging for a shirt and a hat. So, they are going to the soccer fields.

So, with all of the time and money invested to build up the youth leagues up and to build the fields up in the 5-6 years he was out there, with a stroke a pen council has wiped it out. The vote was 7-0. There is plenty of land if they want to have a dog park. They don't have to ruin two ball fields. Mr. Davis wants to know what we are doing for our youth. We will take care of the dogs but not the children.

Ms. Marchese said this is the first she has heard this is going there and she has questioned it herself numerous times. Mayor Mientkiewicz said it has been talked about multiple times. Ms. Marchese wants to know what will happen with the children's playground. Ms. Marchese wants to know why it has to be right next to the children's play area. Mr. Davis stated it is going there to support the Wellness Center. It can go over across the street instead of ruining the baseball fields. They can bring back youth baseball. Mr. Davis says this is sad.

Auditor Merlo explained that the operations of the park are more than the levy.

MISCELLANEOUS REMARKS

(Miscellaneous remarks began at 25:03 into recording)

Mayor Mientkiewicz expressed his appreciation to everyone involved on the water department project. This became a concern about two years ago and this has been a concern of the fiscal commission and the can got kicked down the road. For the last five months, he appreciates everyone getting on board and coming together to move this project forward. The employees are excited about this transition.

Auditor Merlo updated council on the asset management project. Auditor Merlo did receive a preliminary report today. They should be completed by the end of next week. They did send all of the property appraisals and what those values are. The administration, department heads and himself are looking at those and making sure those are correct.

Mr. McNaughton asked when this is complete, when might we be able to formally apply for release from fiscal emergency. Auditor Merlo and Mayor Mientkiewicz said we will find out at the Fiscal Commission meeting on December 20th. Auditor Merlo said once everything is finalized, he will send the report to council and put it on the record.

Mr. Catanzarite thanked council on behalf of the water department, for getting the building for them. It is long overdue. He appreciates the work they have done. He deferred the rest of his time to Dr. Neopolitan from MVSD. Dr. Neopolitan gave an update to council on interviews that they are conducting for class four operators and they are splitting up their chief engineer into two positions. They have a lot of projects coming up. A lot of things happened there over that last few months but they have things under control. Mr. McNaughton thanked him for coming and giving the update. He was the one who asked for someone from MVSD to come and give an update.

Mr. Pezzano thanked council for passing the resolution about GM, as he is a former retiree from General Motors.

Mr. McNaughton wanted to thank Dr. Neopolitan for showing up to council this evening. He wanted to echo the statements of Mayor Mientkiewicz about the water department. He is glad that we are finally investing in our people and in our infrastructure. We are continuing to update our buildings and making it safe for our workers. They didn't become decrepit two years ago. They have been for quite some time. He is very proud to be part of this crew that has taken on the responsibility to do the right thing by our people and by our residents. This is long overdue. This has been a lot of work done by the administration.

Ms. Marchese is also glad that the workers are getting out of that building. She is not happy where the dog park is going. She would like to see everyone sit down and reevaluate this. She knows the germs and problems they have had at Mosquito Lake. Mayor Mientkiewicz said there is another option. He has been talking to Mr. Burke about another option. Ms. Marchese doesn't

think they can have the dog park that close to where the children are. She doesn't think it is a good idea to have it that close to the play area.

Mr. Kearney wanted everyone to know that the only reason he is wearing an Ohio State jacket is because he lost a bet to Ms. Marchese. Go Blue.
