Mr. Mientkiewicz explained that this is an appropriation for the water meter project. \$500,000.00 was already appropriated. The Service Director and Neco have been working on the contract and decided that additional appropriations would be needed. Service Director Stredney stated that through meetings with Neco, there are items like a diagnostic tool and contingency money built in here. Mr. Mientkiewicz stated that this money is strictly for this project and if any of this money needs to be used, Neco is to notify the administration and the administration has to sign off on the change order. Any money left would return back to the fund that is was appropriated from. If by chance all of the money is spent and more is needed, Neco will have to explain to council and the administration the justification.

Mr. Cantola did ask if we have a time frame as to when this will be completed. Service Director Stredney said they are shooting for the end of this year, however, they will probably be some that linger into 2019. Neco will send out all of the notices and do all of the scheduling for the appointments. He estimates that there are approximately 5600-5700 meters that need to be installed. President Steffey asked if council will be provided with reports on the progress of the installations. Service Director Stredney did confirm that there will be progress meetings weekly with Neco and information will get to council.

Mr. McNaughton commended Service Director Stredney and the administration for the work they did on this contract.

MISCELLANEOUS REMARKS

(Miscellaneous remarks began at 25:00 into recording)

Mayor Scarnecchia informed everyone that the city treasurer resigned last week. He worked diligently on finding a new treasurer. After conducting interviews, Mayor Scarnecchia announced he has hired Mr. Steve Telego. Mr. Telego was a vice president of Cortland Banks for many years. Mayor Scarnecchia also thanked Service Director Stredney for the hard work he into getting the water meter project moving.

Service Director Stredney told council that they are going to asking either utilities or finance for the legislation in regards to the gas aggregate plan so it can be brought to the voters in November.

Chief Holland stated that at in the parking lot of the Wellness Center for the next few days, there will be a brand new \$100,000.00 driving simulator there for training for the officers. He invited council and the administration to go and take a look at the simulator and watch the officers.

Mr. Burke told council that on this Thursday, he is having a softball meeting with teams, and coaches about possibly starting an adult softball league. Also, he let everyone know that the next 5 minutes with the Park Director meeting will be March 1st at 5:00 P.M. at the Wellness Center.

Mr. Lastic stated that he is glad to be back.

Mr. McNaughton congratulated Mr. Burke on the phenomenal job he is doing. He thinks it's fantastic that he is taking the time to meet the members of the community and it's a good model to try and follow. He also reminded everyone that himself and Mr. Profato are taking a bus trip on Wednesday to Columbus to advocate for the project at Eastwood Field. President Steffey pointed out that Mr. McNaughton and Mr. Profato are paying for this trip out of their own pockets because they feel so strongly about it.

Mr. Profato pointed out that the precinct committee still has 45 days to appoint a treasurer. Law Director Swauger stated that as of now the position is an interim treasurer until the final appointment.

Mr. Cantola had two questions. He would like to continue to see the overtime report because he feels they need to follow up on that. He stated that he is getting questions in regards to the GPS systems. He asked for clarification on how the records are being maintained for the GPS systems. Service Director Stredney informed him they are digitally stored by Verizon and we go through they portal. People have put in public record requests for them and as long as is it within the time period that the system will hold, he has given the report.

Mr. Cantola asked how long the time period is and Service Director Stredney stated he believed there was a 5 day window on it, or 7. Mr. Cantola doesn't think that time frame is long enough. Law Director Swauger said the time frame requirements are from Verizon. He offered to check with Verizon and get more information on the retention period is. Mr. Cantola thinks this is an awesome tool because the Service Director should know where his trucks are and how many hours they are on the street. He should be able to pull further back in the system than 5-7 days. Law Director Swauger said that time frame might be all the city has access to but Verizon can

pull reports further back. He will check on this. Mr. Cantola mentioned it would be nice for someone from Verizon to come and give them information on this tool.

Mr. McNaughton did ask Service Director Stredney if he has ever seen a discrepancy while reviewing these reports. Service Director Stredney said there have been complaints where people say trucks are cutting trees on private property or the backhoe was taking down fences on Saturday afternoons. He has been able disprove the allegations by viewing the reports for the GPS.

President Steffey did agree that is a value to have this system and he looks forward to hearing from Law Director Swauger about the time frame.

Mr. Mientkiewicz asked Service Director Stredney about the overtime report. He wanted to make sure that council would still be getting an amended version of the overtime report for the first meeting in March. Service Director Stredney said that would be feasible. He explained the changes to the report and how the report will now show what the budgeted amount for overtime per department would be. For example, if the Light department was budgeted for \$100,000.00 Council would be able to be see how much of that \$100,000.00 they used every month. They can monitor how close to their budgeted number they are getting to throughout the year.
