MISCELLANEOUS REMARKS

The Mayor had a quick note on the final breakdown of the Niles Times Building about the financials, approximately \$17,000.00 in invoices was apprised for labor and fuel costs through the engineers office. We received \$5,000.00 approximately in strap bags from Niles Iron and Metal for a total project cost net of \$12,000.00. This is the second major project that was very beneficial to the community and saved the City a ton of money. Participation from the COG for these types of projects are very beneficial.

The Treasurer sent everyone an email today regarding RITA information, he just received some RITA updates from the end of August and if you go through the email and look at some of the

monthly and annual charges, it seems like some of the good news is with the comparisons of other years and months, we may hit the Nine Million Dollar mark this year. That's good news as long as things continue to go in the direction that they are going in. If there are any questions you can email the Treasurer and he will give you a response.

Chief Holland stated that his two new officers are working out well.

Mr. Sollitto was wondering if we had an update yet on the restroom for the park. He knows we were waiting on the grant. The Mayor stated they had some communication with ODNR and they needed the Kennedy Park Deed and we were not able to locate that in the City Building so we had to do a record search. We did locate the deed and we are waiting on the company to send us the deed so we can send it down to the state.
