COUNCIL MEETING MINUTES June 21, 2023

Niles City Council held its regular meeting on June 21, 2023, at 6:00 p.m. at the Niles Middle School in Niles, Ohio.

The meeting was called to order by Council President, Robert Marino Jr., and the Clerk, Nicole Bacak, called the roll:

It was moved by Smith, seconded by Sollitto to accept the minutes from the June 7th meeting and place them on file.

MEMBERS OF THE AUDIENCE TO ADDRESS COUNCIL

(Public comments began at 1:32 into recording)

James Sheely: Mr. Sheely wanted to address an issue with a house on Cedar St., across the street from D'urso's bakery. Unfortunately, the person who lives there has been taken advantage of for many years. Mr. Sheely met with Mr. Stredney about this issue when Mr. Stredney was on council and voiced his concerns about all of the drugs, etc. going on at this house. Mr. Sheely said the person who owns the house is no longer there because he had a heart attack, but other people have taken up residency in this home. President Marino asked if he has spoken to the law director about this issue and he said he has not.

President Marino advised him to take this concern to Law Director Zuzolo instead of addressing it at city council. He doesn't want to restrict his speech, but he would encourage him to do that because he is aware of this situation, and it does go way back. He would like Mr. Sheely to speak to Law Director Zuzolo and maybe even meet with the police department to discuss it in private because there might be an investigation happening that they are not privy to.

Tom Cantola: Mr. Cantola is here this evening to discuss an ongoing issue with the billing department that he has been having. He has lived at his address for the last 6 years and he pays his bill every 2-3 months. He has never had an issue and has never been a problem. Three months ago, he paid his bill, and it was applied to his parent's account. It happens all the time and it was corrected. The amount on the check was altered when it was deposited. He called his bank, talked to the city and there was a miscommunication, and everything was fixed.

Joking around with the employees at the billing office about the error, he said see you in three months. Last week, he was on vacation and his utilities got shut off. He called and got nothing but attitude from the head of the department. There was screaming and yelling and everything else and it was very unprofessional. His issue is that the person at the top doesn't know what is going on and doesn't know the law. According to Mr. Cantola, it is against the Ohio Administrative Code to call him 24 hours before shutting off his utilities. It states you need to give a 14-day notice and something needs to be left at the residence when you turn off the utilities, and that was not done.

At this point, Mr. Cantola feels that this is retaliation against him because of the issues he has had with the billing department. He dropped the last issue, but he is not dropping this. He is moving forward with this issue. Mr. Cantola said everyone here should be embarrassed about how a city employee talks and acts to a resident. He would never be able to get away with this type of behavior at his current job. Mr. Sollitto interjected and said that he would believe the mayor is going to call for an investigation or interview because it is outside of their rules of conduct. Without just saying Mr. Cantola is right, he will have to interview that person now that the issue has been raised at council. He is not trying to put words into the mayor's mouth, but he would think that is what would happen. Law Director Zuzolo said he will speak to him after the meeting. Mr. Sollitto asked what the mayor's intentions were with this and Mayor Mientkiewicz said if this involves pending litigation, he will let the law director handle it.

It was moved by Smith, seconded by Lastic to adjourn into executive sessions pursuant to ORC section 121.22 section G to discuss pending litigation.

MISCELLANEOUS REMARKS

(Miscellaneous remarks began at 15:14 into recording)

President Marino asked Mayor Mientkiewicz about the street resurfacing. President Marino asked if the city is coordinating with the company that is replacing the underground utilities. He noticed on Maple Street that the road was paved and then they come over and dig them up. President Marino wanted to know if they have a schedule of the streets that they will be digging up so that they city can shift their paving around if need be. Mayor Mientkiewicz said they did not know about Maple, but they do know now their capital project list over the next few years. He did meet with Dominion and they provided him with a list so that they can coordinate moving forward.

President Marino also asked if there is any update from MVSD about the loans, dam, rates, etc. Mayor Mientkiewicz said MVSD does have a meeting next week about the dam. As of now, the court of jurisdiction did not approve their rate study. They did reapply for the loan, and they are in a good position. Mayor Mientkiewicz did speak to Dr. Neopolitan this morning and he thinks in August they should know where they stand with the loan. President Marino suggested to Mr. Sollitto that in August when they have more information to schedule a meeting with MVSD. Mr. Sollitto said he has also spoken to Mr. Merlo and he knows that he would be interested in coming to speak to them.

Mayor Mientkiewicz announced the retirement of long-time light department employee, James Newbrough. He wanted to wish him a happy and healthy retirement. He thanked him for his many years of service with the light department. Mayor Mientkiewicz also recognized Jill Wilson on her retirement from the dispatch unit. He appreciates both of their time with the city and wishes them the best with their upcoming retirements.

Lastly, Mayor Mientkiewicz wanted to give an update on the Mahoning Ave railroad track removal project. The project did commence today, and he believes that all of the tracks, or most of them, are out and Friday the company will begin paving Mahoning Ave. He appreciates council's support on solving a long-term problem.

Mr. Sollitto gave an update from when Ms. Gentilcore came to council to speak about her issue on Fulton Street. He has spoken to Ms. Marchese, and she knows what is going on. The lady, who is next door, has been noncompliant and it has now reached a level that she will be cited to court. Mr. Crowley is working on this and said it is worse than it was before.

Next, Mr. Sollitto asked about the river where the dock was just rebuilt. He said the dock looks outstanding. He has been to the dock with the mayor, and he knows he is going to have the city look at the dead trees. There have been complaints of flooding and he has talked to the mayor, and he is looking at getting the river drudged. It is being aggressively looked at. Lastly, he wanted to congratulate James Sheely.

President Marino stated that this is council's last meeting until August 16th, which at that time council be back at council chambers at the senior center. He thanked Ms. Devorich, Auditor Merlo and Mayor Mientkwicz for the renovation project over there.
