Dee Sevens: Dee gave a reminder about the Veteran's Brunch at McKinley Heights fire department. Dee also announced a winter family festivity festival on December 7, 2024. She requested funds from Council for this festival. Mr. Sollitto indicated that Dee would need to provide an amount and receipts prior to being provided funds from the City.

Richard Strong: He expressed that the Ohio Revised Code states clearly that the City can do what it wants in regards to the guardrail.

Mayor Mientkiewicz reiterated that it is ODOT's recommendation, not requirement, that the City wait to see if the signs resolve the issue. It is prudent that the City follow best practices, and follow recommendations of traffic, engineering, professionals, and Uniform Traffic Code.

Mayor Mientkiewicz announced that American Legion Post 106 is going to have its annual Veteran's Day ceremony in the Niles City Cemetery at 11:00a.m.

President Marino asked Auditor Merlo about the budget hearings. Auditor Merlo stated that the hearings went well and that they will likely have a Council roundtable to discuss within the next week or so. He noted that Mr. Johnstone had attended some of the meetings.

Mr. Johnstone noted that the pumpkin walk had a wonderful turnout of over 300 children and expressed that he is looking forward to doing it again next year.

Mr. Sheely stated that the brunch for Veteran's Day is from 10:00a.m.-2:00p.m. on Sunday, November 10, 2024 at the fire station. It is \$10.00 per person and veterans eat for free.

Ms. Devorich stated that she hopes the winter festival can grow over the years.

Mr. Sollitto noted that hopefully the city can resolve the guardrail situation once the new engineer takes over.
