A RESOLUTION AUTHORIZING THE CITY OF NILES TO PARTNER WITH AND HAVE BENEFICIAL ELECTRIFICATION LEAGUE (BEL) VIA AMERICAN MUNICIPAL POWER (AMP) SUBMIT AN APPLICATION ON THE BEHALF OF THE CITY TO THE APPALACHIAN REGIONAL COMITSSION (ARC) PARTNERSHIPS FOR OPPORTUNITY AND WORKFORCE AND ECONOMIC REVITALIZATION INITIATIVE (POWER) GRANT PROGRAM VIA THE STATE OF OHIO DEPARTMENT OF DEVELOPEMNT VIA CONGRESSIONALLY APPROPRIATED FEDERAL FUNDS FOR FUNDING FOR THE FEDERAL FISCAL YEAR 2025 FOR FUNDING TO BUILD ELECTRICAL CAPACITY FOR BRT EXTRUSION INC. EXPANSION; AND, DECLARING AN EMERGENCY

WHEREAS, funds are to be available through the Ohio Department of Development ARC POWER program dollars for the purpose of strengthening a variety of industries, including advanced manufacturing, entrepreneurship, healthcare, and workforce development, to bolster re-employment opportunities, create jobs in existing and new industries, and attract new sources of private investment in coal communities, and

WHEREAS, BEL will apply for the grant on the City's behalf, and

WHEREAS, said Grant award amount will be a maximum of Three Hundred and Fifty Thousand dollars (\$402,500); and the City of Niles will provide a maximum of One Hundred and Fifty Thousand dollars (\$172,500) match; and

WHEREAS, the ARC POWER grant is a reimbursable grant and requires awardees to incur costs first then submit to ARC/ODOD for reimbursement; and

WHEREAS, the Department of Development or Appalachian Regional Commission will notify grant awardees in Spring 2026. All awarded projects construction start date will be May 1, 2026; and

WHEREAS, the City of Niles agrees to be responsible and comply with all Ohio Department of Development/Appalachian Regional Commission's Partnerships for Opportunity and Workforce and Economic Revitalization program requirements (state and federal award requirements); and

WHEREAS, the City of Niles will return to Niles City Council with more detailed information about the grant and partnerships if grant is awarded in the Spring of 2026. At that time the City will request City Council approve it to accept the grant and also go out to bid for a contractor for the project.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NILES, STATE OF OHIO:

SECTION 1: That Authorization is given to the Mayor to submit this application to the Appalachian Regional Commission's Partnerships for Opportunity and Workforce and Economic Revitalization Program in partnership with the Ohio Department of Development as the Basic Agency over ARC Construction projects.

SECTION 2: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, convenience and welfare of the City of Niles and the inhabitants thereof, for the reason that it is to apply for this funding within the next 30 days, and provided that it receives the approval of two-thirds of the members of Council, shall be in full force and effect from and after its passage

and approval; otherwise to be in full force and effect from and after the earliest period allowed by law.
