# MEMBERS OF THE AUDIENCE TO ADDRESS COUNCIL FOR GENERAL PURPOSE

(Public comments began at 6:32 into recording)

Richard Strong: Mr. Strong addressed council with concern for the basketball hoops in Murphy Park that were taken down without notice to residents of their removal. Mr. Sheely responded that he requested new mulch, new swings, and taking down the damaged basketball hoops but only the basketball hoops were addressed. Mr. Sollitto proposed that we present this issue to the Public Grounds Committee considering the backlash they have faced surrounding the basketball court/hoops. Sollitto added that he would like to see new basketball hoops go back in at Murphy Park despite the negative activity and vandalism that goes on because it sends the message that the City would rather they not have any activity at the Park. Mayor Mientkiewicz added that the Park Department has ordered new swings but the basketball hoops being removed were a result of repetitive damage, lack of use, and continuous negative activity. Sheely added that although there is some negative activity at the park, the issues stem more from a lack of maintenance and he would like to see the City upkeep the maintenance at Murphy Park as much as they address issues at Waddell.

Council President Marino presented the historical importance of the park and does not wish to see parts of the park be eliminated just because of the few bad incidents that have occurred there. Marino encouraged Sheely to meet with Park Board Chair, Park Board Director and Mayor to share concerns and get an understanding of the intent of the park.

Mr. Strong re-addressed the issue of vandalism of the swings and basketball hoops, adding that there is a product that can be sprayed on clear but will allow any graffiti to be wiped off easily. Strong does not want everyone in the 3<sup>rd</sup> Ward to be punished for the negative activity of just a few and he suggested that there be a stronger police presence to monitor the activity in the park.

Mayor Mientkiewicz added that a plan was made in the summer to fix the swings, add mulch, and address the damaged hoops at Murphy Park, and albeit it is being addressed slowly, it is still in the works and the other improvements will be made.

#### MISCELLANEOUS REMARKS

Mr. Marino congratulated Maryann, Ed, and Frank on their elections as well as the other council members on their re-elections.

Mayor Mientkiewicz provided an update on the Appalachian Community Grant Program for Riverside Park on First Street is about 70% completed and Downtown Public Square is about 30% completed. Both of these projects should be completed by early Spring.

Mr. Weddell offered his congratulations to the newly elected council members.

Mr. Johnstone also offered his congratulations to the newly elected council members as well as those who were not elected but put their name out there to try and make Niles a better place. Johnstone highlighted the Niles Girls Soccer Team for their great season. Johnstone also highlighted Niles Intermediate School for being voted One of the Best Elementary Schools for the 4<sup>th</sup> time. Mr. Johnstone added that the next CIC meeting is November 13 at 4:30 at the Wellness Center.

Mr. Sheely also congratulated those who won their elections as well as those who may not have won and encouraged the community to continue to push Niles in the right direction.

Mr. Julian also offered his congratulations.

Mr. Lastic thanked Niles for his re-election.

Mr. Sollitto encouraged setting a Public Grounds meeting to address the issues presented at tonight's meeting.
