With the research they did, they showed everyone the viability and rejuvenation of the Mahoning River. He is thrilled that they joined council and presented in front of a bunch of strangers. They articulated very well and should be very proud of what they accomplished this evening. They could not be prouder of the students in the Niles City Schools.

MEMBERS OF THE AUDIENCE TO ADDRESS COUNCIL FOR GENERAL PURPOSE

Richard Strong: Mr. Strong stated he was not there for a political thing. He would like to see on October 14th; the City of Niles fly the flags at half mast in remembrance of Charlie Kirk. He would like this to be considered. Mayor Mientkiewicz said they follow the orders and direction of the governor's office.

Michael Cricks: Mr. Cricks wanted to touch base on the dealership being built. He wanted to thank them for keeping the retainment on the back of Shaw Rd. He has met with Mr. Wheeler from the city about other things, such as detention ponds and trees to keep some privacy and noise out. Mr. Johnstone said there have been discussions with boundaries.

Mr. Johnstone said they came to council approximately a year ago and asked for the current tree line not to be disturbed. They also discussed a traditional buffer. Mr. Johnstone said they were originally in agreement with this, and they had not said they weren't going to do it. He has all of the confidence that they will honor what they originally said in front of council. Mr. Sollitto agreed and said the dealership has been more than gracious and are willing to be partners.

President Marino said he was the one who asked for the buffer zone and the tree line not to be disturbed. In his experience, he knew what to ask for. Buffer zones are one thing and once the leaves fall from the trees, you will see right into the area. It sounds like everything is worked out. Mr. Johnstone said there is no written agreement, and they are just waiting on Mr. Wheeler to get something in writing.

It was moved by Sollitto, seconded by Lastic to grant an additional three minutes. Motion carried.

Mr. Cricks hopes things can be put in writing and he doesn't see any issues. He thinks everyone on Shaw Rd. will be happy. Mr. Johnstone said there are others who will be affected by this. It is exciting with all of the growth in the city and the city moving forward, but there is another side to the sword for the neighborhoods. He is sympathetic and wants this to be as painless as possible and appreciates the residents' cooperation through this process. Everyone has been great to work with through the process, so he has no reason to think that they will not honor what they said.

MISCELLANEOUS REMARKS

Mayor Mientkiewicz wanted to publicly thank Mr. Dave Sheely and his team at the local VFW for their generous donation of \$12,000.00 to the safety forces. The city is very appreciative and thankful for everything they do for the veterans. They also make donations to the youth groups, which the mayor wanted to recognize.

President Marino asked the clerk and law director to draw up a letter and send it to Niles Middle School thanking the students for their presentation.

Service Director Flarey thanked council for approving the Brown Street pipe project.

Mr. Johnstone wanted to inform everyone about two events happening in the city. The Niles Historical Society, along with the Thomas House, will be putting on a fall market on Sunday, October 12th @12:00 P.M. Also, the Niles McKinley Library Museum is having their 6th annual Halloween party and pumpkin walk on Saturday, October 18th @5:00 P.M.

Mr. Sheely wanted to add to the mayor's comments of the VFW. He encouraged people to stop down there and visit. The veterans do a lot for the community. They have sacrificed a lot for us and the nation. He encouraged people to go down there and sit with them and honor them for what they have done and continue to do. He has a lot of family members who have served in the military and holds them to the highest standard.

Mr. Sollitto agreed and said the people at the VFW are first class. They are always giving back to the city and a true blessing to the city. He also wanted to thank public grounds, and council as a whole for following through with the resurfacing of the track at the park. He thinks it will be a great thing to help the Little Red Dragons, and help the citizens of Niles.
