Lois Nickel: Mrs. Nickel was back at council tonight to address an opt-out option for the installation of a smart meter on her house. She refuses the required installation of this smart meter.

Julian explained to her the result of the Utilities Committee meeting held on September 11<sup>th</sup> that over 90% of the new meters have been installed, they are certified by the FCC, they are compliant with the EPA and FDA, and there is no other reason to allow an opt-out option at this point in time. Julian further explained that her current meter model is 30+ years old and will need replaced eventually.

Mrs. Nickel refused to accept this as an answer and reiterated her concern about radiation and carcinogens that may be emitted from the new smart meters.
