Sites Exempt from Stormwater Approval

Sites requiring stormwater approval include grading, excavating, grubbing, filling, and demolition.

Sites exempt from approval are:

- Utility work, post and pole installation, parking lot and driveway repair under 1 acre.
- Minor work on single lot performed by single owner/ contractor, < 10,000 sf.
